

## **TOWN OF WHITEWOOD**

### **BYLAW NO. 01-2010**

#### **A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF THE SEWER**

**WHEREAS** the Council may regulate the distribution and use of water in the Municipality and may fix the price for the use thereof and the time of payment; and

**WHEREAS** it is deemed necessary that the properties of premises drained or required by Bylaw to be drained into the sanitary sewer system shall be charged a reasonable rent or service charge for the use of said sewer;

**NOW THEREFORE**, The Council of the Town of Whitewood, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Municipality's water system shall make application to the Officials of the Municipality. Each application shall be accompanied by the payment of a meter deposit in the amount of \$90.00.
2. The Municipality may ration or limit the amount of water furnished to any and/or all consumers should circumstances deem to warrant such action.
3. The property owner shall provide a frost proof location for the water meter that is readily accessible for the purpose of obtaining meter readings.
  - a) The property owner shall be liable for the full replacement cost of a meter installed on his property where said meter is damaged by frost or other cause.
4. If the water supply is shut off from the premises of a user for infringement of the provisions of this Bylaw, it shall not be turned on until all penalties, fees, rates, charges, and arrears, if any, have been paid.
5. Water meters shall be read three times yearly.
6. The charges to be paid by the consumer whose water service has been turned on shall be those set forth in Schedule "A" hereto, or as amended from time to time; provided, however that the minimum shall be payable in every case whether or not any water has been consumed.
7. Persons who own or occupy premises drained or that are by Bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" hereto, or as amended from time to time.
8. Accounts for water and/or sewer services shall cover a period of three successive months, and shall be rendered on the first week of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which the same was rendered. In case an account is not paid within thirty days in which the same was rendered, there will be added to and form a part of the bill a ten percent penalty. If after sixty days from the date of the billing, the account is not paid in full, including the late penalty, the water service may be cut off. When the water service is so cut off, it shall not be resumed until all arrears have been paid, together with a fee of Twenty-Five dollars (\$25.00) to cover the expenses of turning off the water and turning it on again.

9. Bylaw No. 3-2008 is hereby repealed.

This Bylaw shall come into force and take effect on the day of approval thereof being issued by the Saskatchewan Municipal Government Board.

SCHEDULE "A"  
TO BYLAW 01-2010**

MONTHLY WATER RATES:

In all cases where water services are provided for by the municipal water system the following rates shall apply:

- (a) A monthly rate of \$59.00 shall be charged where the amount of water does not exceed 3,000 gallons per month.
- (b) Where the amount of water used in any calendar month exceeds 3,000 gallons, a rate of \$6.00 shall be charged for each 1,000 Gallons used, or portion thereof, in excess of 3,000 gallons. This rate shall be referred to as overage and shall be charged in Addition to the \$59.00 monthly rate referred to above in section (a) of Schedule "A"
